Implementing acts

Primary responsibility for implementing EU law lies with EU countries. However, in areas where uniform conditions for implementation are needed (taxation, agriculture, the internal market, health and food safety, etc.), the Commission (or exceptionally the Council) adopts an implementing act.

Delegated acts

The Commission adopts them on the basis of a delegation granted in the text of an EU law, in this case a legislative act.

- The Commission's power to adopt delegated acts is subject to strict limits:
- the delegated act cannot change the essential elements of the law

the legislative act must define the objectives, content, scope and duration of the delegation of power Parliament and Council may revoke the delegation or express objections to the delegated act Tertiary legislation published at Nov 2019 Reg.2016/429


Prioritisation of EU intervention

The new Animal Health strategy must be seen as an integrated **risk assessment** and **risk management strategy** focusing on risks of EU relevance.

 \rightarrow **Categorisation** of biological and chemical risks according to level of relevance for the EU;

- \rightarrow Agreement on the **acceptable** level of risk;
- \rightarrow Setting of **priorities**, quantifiable targets and performance indicators;

 \rightarrow Setting of the amount of **resources** to be committed to identified threats.

Risk vs Hazard



$RISK = HAZARD \times EXPOSURE$



Risk & hazard

- **HAZARD**: any agent (biological, chemical or physical) or condition, with the potential to cause an adverse effect to health
- **RISK**: likelihood of identified hazards causing harm in exposed population in a specified time frame, including the severity of consequences
- **EXPOSURE**: the extent to which the recipient is subjected or exposed to a hazard
