- good Beekeeping Practices (GBPs),
- sanitary legislation and hives registration
- official controls
- quality of the hive products
- bee diseases and their diagnosis and treatments
- HACCP system applied to the bee products
- emerging issues such as the Colony Collapse Disorder (CCD), monitoring activities on the arrival in EU of the Small Hive Beetle (*Aethina tumida*) and *Vespa velutina*
- new products to fight *Varroa destructor*, etc...








Number of training events

At the end of each training events the partecipants expressed their sactisfaction degree by means of questionnaires


First question of the questionnaire:
